4. Approval of minutes from the Special Meeting held March 10, 2022.

A motion was made by Commissioner Croft to approve the minutes as presented. The motion was seconded by Commissioner Giesecke with all Commissioners present voting in favor of the motion.

5. Receive report from the Brazos Pilots Association regarding Communication/Dispatch.

Captain Krohn gave a presentation regarding the communication/dispatch that detailed the history, revenue, expenses and balance for fiscal year March 2021 – February 2022 noting the large expense was due to the purchase of network VHF radios. He also shared a list of all registered users for the system and noted that Brandon Heasley from Vopak is the new Chairperson for the Channel User Advisory Group. Additionally, the group will meet quarterly and report to the Pilot Commission semi-annually.

6. Receive update and recommendation from the Channel User Advisory Group regarding the per vessel movement line-item surcharge for Communication/Dispatch service.

Ms. Colleen Kallestad gave an update for the Channel User Advisory Group stating the group met March 24 to discuss the charges for communication/dispatch service and all users agreed that the current fees in place will stay the same for the next year. All users and customers are happy with the dispatch system and feel the fees are minimal. Ms. Kallestad also reported the group discussed more tug support for the vessel traffic, NOAA Ports System which is on track for August 31 and noted that Capt. Krohn is working with his group on the Coast Pilot updates. The next Advisory Group meeting will be held in June.

7. Discussion regarding the Brazos Pilot Association' request for applications for Deputy Branch Pilot.

Captain Krohn stated that due to increased traffic in the Port and future traffic to come, the Pilots recently requested applications the Port has on file for the position of Deputy Branch Pilot. He noted the decision is not final, but the Pilots want to take a look at what candidates are available at this time.
