SUBJECT: 2021 Revenue Bond Plan of Finance

In line with the FY2024 capital budget and recent board discussions regarding the purchase of two new STS Gantry Cranes, we have been working with our financial advisors and bond counsel on the potential issuance of \$25M in Revenue Bonds. Through modeling exercises and consultation with Masterson Advisors LLC, we believe the best path forward is to issue a 20 year revenue bond with a project funding source of \$25M to be used toward the Cranes and other capital infrastructure projects identified in the approved budget.
